Waste Disposal Levy - Effective 1 July 2023

From 1 July 2023 the Ministry for the Environment (NZ Government) has introduced a Waste Disposal Levy under the Waste Minimisation Act 2008, for disposal of managed or controlled fill. The aim is to encourage the reduction and recycling of waste. The levy is paid into the Waste Minimisation fund and distributed to territorial authorities.

The levy is \$10.00 plus GST per tonne and is applied to all managed fill tipping.

Please see below as to how the levy will be treated:

Clean fill - The levy will not apply:

(Material must also comply with our acceptance criteria i.e. not contaminated)

- Loads of 100% virgin excavated natural material only i.e. Clay/soil/rocks.
- Loads of 100% clean concrete

Managed Fill - The levy will apply:

(Any mixed loads containing man-made materials or contamination)

- Mixed loads Clay/soil mixed with concrete, bricks, rubble etc
- Clay/soil that contains contamination above our acceptance criteria (see below)

We encourage our customers to consider how they can minimise their exposure to the levy e.g. if possible, separate materials to bring clean fill rather than multiple mixed loads.

Please refer to our fill declaration form and waste acceptance criteria. This should be completed in advance and emailed to operation@manukauquarry.co.nz or we will require this to be completed at our weighbridge upon entry to our facility.
